Dear Mrs. Griffin:

As requested, M&S Engineering is submitting for your consideration this contract amendment to assist the City of La Vernia in preparing and adopting a Master Thoroughfare Plan in conjunction with the Comprehensive Plan update.

Scope of Services

- Prepare a Master Thoroughfare Plan (MTP)
 - The MTP will be fundamentally based on the MTP prepared in 2015.
 - Fundamental land and transportation planning principals will be used to prepare the plan. Traffic modeling will not be used in the MTP development.
- Participate in one on one meetings with affected land owners.
- Incorporate MTP language into the subdivision ordinance update recommendations.
- Incorporate the MTP Comprehensive Plan update activities through to adoption.

Owner's Responsibilities

- Provide update on traffic and transportation improvements since 2015.
- Provide updated city limits and ETJ.
- Provide most recent land use plans.
- Provide a summary of current and notable development activities in La Vernia and the ETJ, including and current master development plans.

Schedule

M&S Engineering proposes to provide these services in accordance with the ongoing schedule established for the Comprehensive Plan update.

Compensation

M&S Engineering proposes to complete the scope of work described herein on an hourly rate plus expenses basis for a fee Not to Exceed (NTE) \$10,000 without written authorization from the City of La Vernia. The NTE is a suggested budget amount and the actual cost of providing the services may vary.
