

Re: La Vernia Zoning and Land Use Map Updates

Dear Mrs. Griffin:

As requested, M&S Engineering is submitting this fee proposal to help the City update and implement their zoning and land use maps.

Scope of Work

- M&S will coordinate with the City to update zoning categories for the city.
- M&S will update the Land Use Map section of the Comprehensive Plan to support zoning efforts.
- M&S will assist in preparing written zoning designation descriptions for updated categories.
- M&S will prepare preliminary and final reports as required in the zoning implementation plan.
- M&S will assist with conducting the public hearing to review the Zoning Ordinance.
- M&S will assist with City Council consideration and adoption of the Zoning Ordinance to include attending meetings to support this effort.

Exclusions

- This scope and fee does not include notifications or mass mailing services. We assume the City will complete this effort.
- This scope and fee does not include any attorney fees. It is assumed that the City Attorney will be made available for consultation on issues regarding zoning implementation.

Schedule

M&S Engineering will complete the scope of work described herein as follows:

- Upon approval of task order, M&S will complete the work on a schedule that coincides with the existing CDP update schedule.
- After the public hearing and direction from the City Council, M&S will finalize the zoning ordinance report within 30 days and submit it to City Council for adoption.

Compensation

M&S Engineering proposes to complete the scope of work described herein based an hourly rate amount not to exceed \$12,500 plus reimbursable expenses without prior authorization from the City of La Vernia. This amount represents a suggested budget for this work effort. The actual cost may be different. Should you have any questions, please do not hesitate to contact our office.
