He visited the site and stated existing businesses such as building next door is 6', Pruski's building sits at 3' and when he saw the 48' steel pipe, he knew there was no way a truck can make the turn. The Board of Adjustment is a board that provides a vehicle for citizens to appeal zoning interpretations and decisions of the Building Official, and request variances from the zoning ordinance. The Board may also make final decisions regarding changes, variances, the reestablishment, or termination of nonconforming uses within the City. The Board is a decision board.

The Board meets as needed. All meetings are held at City Hall in the Council Chambers

The Planning & Zoning Commission is responsible for recommending to the Council the creation and modification of zoning districts, as well as reviewing and approving all land plats submitted for filing with Wilson County. They also cooperate with Development District regarding the needs in city development. Duties of the Commission include hearing Zoning cases, Specific Use Permits & Plat approvals and citizens are encouraged to attend and voice their views on the cases. The Commission is a decision making board.

The Commission meets the first Tuesday of each month at 6:30 PM. All meetings are held at City Hall in the Council Chambers.

The Municipal Development District will facilitate growth and development of existing companies, as well as, provide the foundation to effectively recruit new companies to the area by developing and implementing initiative programs. The result of these broad and diverse economic development initiatives will be an increased property and sales tax base for the City of La Vernia, a dynamic economic environment for our business community, and an enhanced quality of life for La Vernia's residents. The MDD Board is a decision making board.

The Municipal Development District meets the 2nd Thursday of each month at 5:00 PM or as needed. All meetings are held at City Hall in the Council Chambers.

The Parks & Recreation Commission assist city staff with the planning of parks and recreation maintenance, and to carry out the tasks that have been assigned to them. The Parks & Recreation Commission assists in all city planned events, such as managing event booths, decorating for events, and assisting in clean-up. This commission is an advisory board only.
