APPLICATION AND GUIDELINES**



## Globe Planter Beautification Grant Guidelines

The MDD will consider, on a case-by-case basis, and may award by its sole discretion a grant to the owner of a commercial or industrial building within the city limits of La Vernia for the globe planter beautification grant program.

1. The MDD will reimburse up to \$200 for one (1) planter to a brick-and-mortar business within the La Vernia city limits if, the applicant purchases the 36x30 matte cobalt blue or the matte white “Jay Scott’s Globe Fiberglass Planter” from eplanters.com or any website/business with the same product.
2. The business must submit their application to the MDD with their business address and approximate placement of the planter. This will also be accompanied with the invoice, stating the color and size of the purchased planter along with written permission of the property or business if the applicant is neither.
3. If the applicant plans to paint or transfer any artwork on their planter, they must submit a copy of their artwork. All artwork *must* be city or La Vernia ISD related. Anything submitted and deemed inappropriate, will be disqualified from the planter reimbursement program.
4. The placement of the planter must adhere to the permission of the property/business owner, deed restrictions, city ordinances and TX Dot restrictions. The MDD is not responsible for any fines or penalties acquired with the purchase and placement of the planter.
5. The MDD has no later than 60 days to reimburse the \$200 to each applicant from the application’s approval date.
6. Only one (1) planter will be considered per business building. However, if there are multiple entrance doors to one building (i.e., business suites), the MDD may consider, on a case-by-case basis, awarding more than one (1) planter per business building.
7. The MDD is not responsible for the purchase or maintenance of plants or the planter itself.
8. The MDD is not responsible if the planter is damaged or vandalized, however, the MDD may consider, if the budget allows, replacing the planter in the next fiscal budget year if the applicant re-applies.
9. The MDD may not expend more than \$5,000 in this grant program from October 1<sup>st</sup> to September 30<sup>th</sup> each year.
